## NIGERIA PRESIDENT



### **His Excellency Asiawaju Bola Ahmed Tinubu, GCFR**

*The President, Commander-in-Chief of the Armed Forces, Federal Republic of Nigeria*

Asiwaju Bola Ahmed Tinubu is the 16th President of Nigeria, sworn in on May 29, 2023. A seasoned politician and key figure in Nigeria's democratic history, Tinubu began his political career in the early 1990s as a Senator representing Lagos West. He was also a prominent member of the pro-democracy National Democratic Coalition (NADECO), advocating against military rule.

From 1999 to 2007, he served as Governor of Lagos State, where he is credited with laying the foundation for the state's economic transformation through reforms in infrastructure, taxation, and public administration. His leadership helped establish Lagos as a model of progressive governance.

Tinubu later became the National Leader of the All Progressives Congress (APC), playing a crucial role in the party's formation and its historic 2015 electoral victory. He holds a degree in Accounting from Chicago State University and has a professional background in finance and the oil sector.

## NIGERIA VICE PRESIDENT



### **His Excellency Sen. Kashim Shettima**

*Vice President of the Federal Republic of Nigeria*

Sen. Kashim Shettima, born on September 2, 1966, is Nigeria's Vice President, serving under President Bola Ahmed Tinubu since May 29, 2023. An accomplished economist and former banker, Shettima is widely respected for his pragmatic leadership and crisis management skills.

He holds a B.Sc in Agricultural Economics from the University of Maiduguri and a Master's degree from the University of Ibadan. Before venturing into politics, he worked in the banking sector, rising to General Manager at Zenith Bank.

His political career began with various commissioner roles in Borno State before becoming Governor from 2011 to 2019. His leadership during the height of the Boko Haram crisis earned him praise for resilience and focus on rebuilding education and infrastructure. In 2019, he was elected Senator for Borno Central before becoming Vice President.

## INDONESIA PRESIDENT



### **Mr. Prabowo Subianto Djojohadikusumo**

**Honourable President, Federal Republic of Indonesia**

His Excellency Prabowo Subianto is the 8th President of Indonesia, sworn into office in 2024. A seasoned statesman, businessman, and retired lieutenant general, he brings decades of military and political experience to the presidency.

Born on October 17, 1951, into a prominent political and economic family, Prabowo trained at the Indonesian Military Academy and received further education in Germany, the U.S., and Jordan. He had a distinguished military career, rising to command the elite Special Forces (Kopassus) and the Army Strategic Reserve (Kostrad), playing key roles in national security during the 1980s and 1990s.

After retiring from the military, he founded the Great Indonesia Movement Party (Gerindra) in 2008. Though unsuccessful in earlier presidential bids, he served as Minister of Defense (2019–2024) under President Joko Widodo, where he led major reforms in defense modernization and regional security cooperation.

Elected president in 2024, Prabowo is the third military leader to hold the office and the oldest first-term president in Indonesia's history. His administration is focused on economic reform, national resilience, food and energy security, and strengthening Indonesia's global influence.

## INDONESIA VICE PRESIDENT



### **His Excellency Gibran Rakabuming Raka**

**Vice President of the Republic of Indonesia**

His Excellency Gibran Rakabuming Raka is the 14th and current Vice President of the Republic of Indonesia, having assumed office on October 20, 2024. At age 37, he became the youngest vice president in Indonesia's history, serving under President Prabowo Subianto. As vice president, he holds the second-highest executive office in the country and ranks first in the presidential line of succession.

Before his national role, Vice President Gibran served as Mayor of Surakarta (Solo) from 2021 to 2024, where he earned a reputation for efficient leadership and people-centered governance. He is also a successful entrepreneur, having founded notable businesses such as Chilli Pari and Markobar, and is widely recognized for blending innovation with grassroots development. Born on October 1, 1987, he is the eldest son of former President Joko Widodo.

Educated in Singapore and the United Kingdom, Gibran holds a degree from the University of Bradford. His vice presidency marks a generational shift in Indonesian politics, with a focus on economic modernization, digital transformation, and youth inclusion. His leadership continues to resonate strongly with younger voters and the emerging business class across the country.



### **HER EXCELLENCY, DR. JUMOKE ODUWOLE MFR**

**The Honourable Minister of Trade and Investment, Federal Ministry of Industry, Trade and Investment, Federal Republic of Nigeria. (FMITI),**

Dr. Jumoke Oduwole is a prominent policy reformer and legal expert, currently serving as Nigeria's Minister of Industry, Trade and Investment. Appointed by President Bola Ahmed Tinubu GCFR, she spearheads initiatives aimed at restoring investor confidence and fast-tracking economic growth. Her strategic leadership in trade negotiations and business climate reforms has significantly strengthened Nigeria's position as a top global reformer. Prior to her ministerial role, Dr. Oduwole served as Special Adviser to President Tinubu on PEBEC and Investment (2023–2024) and previously held key roles under President Buhari, where she led over 200 business reforms. Her achievements include improving Nigeria's standing in the World Bank's Doing Business rankings. In recognition of her impact, she received the national honor of MFR in 2023 and was inducted into MIPAD's Hall of Fame in 2024 for her exceptional contributions to national development.



### **HIS EXCELLENCY, BUDI SANTOSO**

**The Minister of Trade, Republic of Indonesia**

Budi Santoso (born 9 February 1968) is an Indonesian politician currently serving as the country's Minister of Trade, a position he assumed in October 2024 under President Prabowo Subianto's administration. Before his ministerial appointment, he served as Director General of Foreign Trade from December 2022 to August 2024, where he played a key role in expanding trade partnerships and reforming export-import regulations. A seasoned bureaucrat, Santoso previously held positions such as Secretary-General at the Ministry of Trade and Trade Attaché in India and Taipei.

As Minister, he has championed sustainable trade practices, export-driven growth, and stronger regional cooperation.



### **HIS EXCELLENCY, AMB. YUSUF MAITAMA TUGGAR OON**

**Honourable Minister of Foreign Affairs Federal Republic of Nigeria**

Ambassador Yusuf Maitama Tuggar, OON (born 12 March 1967) is Nigeria's Minister of Foreign Affairs, appointed on 21 August 2023 by President Bola Ahmed Tinubu GCFR. A seasoned diplomat and politician, he served as Nigeria's Ambassador to Germany from 2017 to 2023, where he played a leading role in returning 22 Benin Bronze artefacts valued at over €100 million and spearheaded key energy and investment initiatives. Prior to his diplomatic career, he represented Gamawa Federal Constituency in the House of Representatives from 2007 to 2011.

As Foreign Minister, Tuggar has advanced Nigeria's "4-D" foreign policy focus—Democracy, Development, Demography, and Diaspora—while advocating robust economic diplomacy under global uncertainty.





### **HIS EXCELLENCY, SUGIONO**

**The Minister of Foreign Affairs, Indonesia.**

Sugiono (born 11 February 1979) is an Indonesian politician currently serving as the Minister of Foreign Affairs, a position he assumed in 2024 under President Prabowo Subianto's administration. Prior to his appointment as foreign minister, Sugiono held the role of Deputy Chairman of the First Commission of the House of Representatives from 2019 to 2024, where he was responsible for overseeing defense, foreign affairs, and communications.



### **HIS EXCELLENCY, AMB. BAMBANG SUHARTO**

**Indonesian Ambassador to Nigeria**

Bambang Suharto (born 12 April 1966) is an Indonesian diplomat who is currently serving as ambassador to Nigeria, Benin, Burkina Faso, Ghana, Liberia, Niger, Sao Tome and Principe, Togo, and the ECOWAS since 24 March 2025.

He studied international relations at the Airlangga University in 1984, graduating with a bachelor's degree in 1990. He then pursued his master's degree in international politics at the Middlebury Institute of International Studies at Monterey from 1995 to 1997.

In August 2024, President Joko Widodo nominated Bambang as Indonesia's ambassador to Nigeria, with concurrent accreditation to Benin, Burkina Faso, Ghana, Liberia, Niger, Sao Tome and Principe, Togo, and the ECOWAS.



### **HIS EXCELLENCY AMBASSADOR USMAN ARI OGAH**

**Nigerian Ambassador to Indonesia (FMR)**

Ambassador Usman Ari Ogah holds a Bachelor's Degree in International Studies from Ahmadu Bello University, Zaria, and has over three decades of extensive experience in international relations and diplomacy. He served in the Ministry of Foreign Affairs from 1993 until his retirement in January 2024.

During his illustrious career, Amb. Ogah rose to the position of Director and served as the Consul General of Nigeria to the Republic of Equatorial Guinea. He has held several ambassadorial positions, including Ambassador to the Republic of Indonesia and the Republic of Timor-Leste. Additionally, he represented Nigeria as the Ambassador to the Association of Southeast Asian Nations (ASEAN). His diplomatic service also extended to postings in Paris, Saudi Arabia, South Africa, Greece and Argentina.
